CONDITIONS OF ADOPTION:

1. I AM AWARE OF THE COST/CARE A PET REQUIRES.
2. I AGREE THE ADOPTED ANIMAL CANNOT BE SOLD OR GIVEN AWAY.
3. I AGREE I WILL RETURN THE ADOPTED ANIMAL TO THE SPCA IF I CANNOT CARE FOR IT HUMANELY. THIS APPLIES ONLY FOR THE FIRST YEAR.
4. IF THE ANIMAL I HAVE ADOPTED IS NOT ADAPTING TO MY HOUSE, I MAY RETURN THE PET WITHIN 30 DAYS AND I WILL RECEIVE A REFUND OF MY ADOPTION FEE. AFTER 30 DAYS I WILL NOT RECEIVE A REFUND.
5. THE SPCA MAKES EVERY ATTEMPT TO ADOPT HEALTHLY PETS. HOWEVER, IF THE ADOPTED PET BECOMES ILL, FROM WHAT IS DEEMED A SHELTER-RELATED ILLNESS, THE SPCA WILL TAKE RESPONSIBLILITY FOR THE MEDICAL NEEDS OF THAT ANIMAL. THE DIAGNOSIS AND MEDICAL CARE MUST COME FROM A SHELTER AUTHORIZED VET.
6. I AGREE TO KEEP ALL TAGS ON MY PET THAT ARE REQUIRED BY LAW AND THE SPCA.
7. I AGREE THAT I WILL PROVIDE AN ADEQUATELY FENCED YARD OR PROVIDE THE PET WITH ADEQUATE EXERCISE UNDER HUMAN CONTROL. I UNDERSTAND THAT SIMPLY CHAINING A DOG IN THE YARD FOR EXTENDED PERIODS VIOLATES THIS PROVISION.
8. IF THE ANIMAL/S I HAVE ADOPTED IS/ARE NOT ALREADY SPAYED/NEUTERED, I AGREE TO HAVE A VETERINARIAN STERILIZE THE PET AT FIVE TO SIX MONTHS OF AGE.
9. I UNDERSTAND I HAVE TWO OPTIONS FOR THE SPAY/NEUTER OF MY PET:
 - A) I MAY TAKE THE PET TO ONE OF THE VETS LISTED ON THE SPAY/NEUTER CERTIFICATE
 - B) I MAY TAKE THE PET TO A VET OF MY CHOICE BUT IT WILL BE AT MY EXPENSE, THE SHELTER WILL NOT REIMBURSE FOR THIS.
10. IN THE EVENT THAT I FAIL TO LIVE UP TO THE TERMS OF THIS AGREEMENT AND IT BECOMES NECESSARY FOR THE SPCA TO TAKE ACTION TO RETURN THE PET TO THE SHELTER FOR THE PET'S SAFETY, I AGREE TO PAY THE SPCA THE SUM OF \$175 AS AN ADMINISTRATIVE COST FOR " LIQUIDATED DAMAGES", THE SPCA COURT COSTS AND RESONABLE ATTORNEY FEES REQUIRED THE SPCA COURT COSTS AND REASONABLE ATTORNEY FEES REQUIRED IN THE RETURN PROCESS.
11. ALTHOUGH THE SPCA MAKES EVERY ATTEMPT TO PROPERLY EVALUATE SHELTER ANIMALS FOR SUITABILITY, I RECOGNIZE THAT ANIMALS HAVE DIFFERENT RESPONSES TO HUMAN BEINGS AND THEIR ACTIONS. THE BEHAVIOR OF THE ANIMALS MAY CHANGE AFTER IT LEAVES THE SHELTER AND ACCUSTOMS ITSELF TO A DIFFERENT HOME. ITS BEHAVIOR MAY NOT BE PREDICTABLE AT ALL TIMES. AMIMALS SHOULD BE SUPERVISED AT ALL TIMES AROUND SMALL CHILDREN. TAKING THE ABOVE INTO CONSIDERATION, IT IS UNDERSTOOD THE SPCA MAKES NO CLAIMS OR REPRESENTATION AS TO THE TEMPERMENT, HEALTH, DISPOSITION OF ANY ADOPTED ANIMAL.
12. I ACCEPT POSSESSION, TITLE AND RESPONSIBILITY FOR THE ADOPTED ANIMAL AND AGREE TO INDEMNIFY AND HOLD HARMLESS FOREVER THE SPCA FROM LIABILITY FOR ANY INJURY OR DAMAGES TO ANY PERSON, PROPERTY OR OTHER ANIMALS THAT MAY BE CAUSED IN THE FUTURE BY SAID ANIMAL.
